Policies and Procedures regarding

C VID-19

As we prepare to return to dance the following guidelines will be implemented to ensure a safe place for our dancers, their families, and our staff.

Our current policies and procedures are outlined here.
We reserve the right to change our policies as new guidelines are established by state and/or local authorities.

Policies & Procedures

Face Mask Policy

Dancers and staff must wear a face mask in the studio, hand sanitize when entering, and must maintain 6ft social distance at all times. Masks with ear loops are required.

Dancers will be given regular, monitored "mask breaks" while social distancing in dance class.

Classes

Class sizes are limited. Dancers will be assigned an individual 6ft x 6ft space for class to ensure 6ft social distancing at all times. We have built-in a minimum break of (15) minutes between student groupings to ensure time for cleaning, sanitizing, and socially distant entry and exit. All classes will remain together and in the same dance room. Instructors will transfer to each room as needed. Each studio has its own bathroom. Studio C dancers will use the hallway bathroom. Bathrooms will be cleaned and sanitized frequently. Hand sanitizers and first aid kits will be provided in each classroom. Frequent hand sanitizing will be encouraged. Studio Equipment such as barres and mats will be sanitized after each use. We strongly encourage the dancers to bring only the necessary shoes for class and a water bottle.

No eating is allowed in the studios at all times.

Entry & Exit

We will be using the front door and the rear loading dock door to enter. Any student with classes in Studio B should enter through the loading dock door. We will have staff conducting temperature screening at both doors. Anyone with a temperature of 100.4 or above will not be permitted to enter. Parents that drop off their students should wait until their child has been admitted before they leave. We ask all students to review the daily health assessment before coming to the studio. Please arrive at your scheduled class time, if you are early you must wait in the car. For young children ages 3 & 4, one parent or guardian will be allowed to escort the child into the waiting room no more than 5 minutes prior to class time. Please try to maintain 6 ft. social distancing while waiting. Please exit the studio once the teacher has collected your child.

One guardian may return to the studio for pickup no more than 5 minutes prior to the end of class.

Masks are required at all times.

Waiting Room Closed

The Front Desk, waiting room and restrooms are closed to visitors. Contactless transactions are preferred. If you need to contact the front desk, please call or email. At this time we cannot allow family and friends to stay in the waiting room. We will revisit this policy as the year continues. Please make sure your contact information is up to date so that a staff member can quickly contact you during class if necessary. We recommend that you wait in the parking lot in your car while class takes place. Please note there is extra parking in the rear of the building.

Please do not park in the loading dock area.

Daily Health Assessment

- 1) Has your child had a fever in the last 48 hours?
- 2) Is your child experiencing a cough, shortness of breath, sore throat, loss of smell or taste or flu-like symptoms?
- 3) Has your child been in close contact with someone who has or may have COVID-19?
- 4) Has your child traveled outside of the state of NH in the last 2 weeks with the exception of MA/ME/VT?
- If you answered YES to any of these questions, please stay home and contact the studio at your earliest convenience.
- If you answered NO, please remember to wear a face mask inside facility and hand sanitize when entering.
